"The constitutional amendment to prohibit the taking, damaging, or destroying of private property for public use unless the action is for the ownership, use, and enjoyment of the property by the State, a political subdivision of the State, the public at large, or entities granted the power of eminent domain under law or for the elimination of urban blight on a particular parcel of property, but not for certain economic development or enhancement of tax revenue purposes, and to limit the legislature's authority to grant the power of eminent domain to an entity."

"Enmienda constitucional que prohíbe la toma de posesión, los daños, o la destrucción de bienes privados destinados al uso público, a menos de que tal acción sirva para la posesión, utilización y usufructo de los bienes por el Estado, por una subdivisión política del Estado, por el público en general, o por entidades a las que se conceda el poder de dominio eminente por ley, o para la eliminación del deterioro urbano de determinada parcela de la propiedad, pero no para fines de desarrollo económico o del aumento de sus ingresos fiscales así como para poner límites a la autoridad de la legislatura para conceder el poder de dominio eminente a alguna entidad."
