4. You may request a driver safety course. You must submit to the Court a written request prior to your appearance date. Requirements, instructions, and form can be located on the next page.

This is my written request to take the "DRIVING SAFETY COURSE". **MUST BE APPROVED BY THE COURT PRIOR TO TAKING.**

You are **not** eligible for DSC if:

- a. You were speeding 25 MPH or more above the posted speed limit.
- b. Your speed was 95 MPH or more.
- c. Your offense occurred in a construction zone with workers present.
- d. Your offense is for pass/overtake school bus.
- d. You are a commercial driver's license (CDL) holder or at the time the offense was committed.

FOLLOW ALL THE STEPS BELOW:

- A. Enclose a **NON-REFUNDABLE** fee of **\$132.00 or \$157.00 if in a school zone** in the form of a **CASHIER'S CHECK OR MONEY ORDER**.
- B. My Texas driver's license number is _____ (COPY MUST BE INCLUDED) or proof of active duty military service if I possess a non-Texas driver's license. (a photocopy is acceptable) **NO ORIGINALS PLEASE.**
- C. I hereby enclose proof of financial responsibility (liability insurance). **MUST BE INCLUDED**
- D. I affirm that I have not taken a Driving Safety Course in the previous 12 months and I am not currently enrolled in one.
- E. I will submit proof of completion of a Driving Safety Course approved by the Texas Department of Public Safety within 90 days from my request date.
- F. Enclose a self-addressed stamped business size envelope in which the Court will mail me an application for a certified copy of my driving record which I will send to Austin with proper fees as required by law. You may also obtain your driving record online at: <https://www.txdps.state.tx.us/internetforms/forms/dr-1.pdf>. Order form 3A. I will submit my driving record to the court within 90 days from request date.
- G. I understand that this form must be notarized.

If you have met the above requirements, you are eligible for the course and are **responsible for completing** an approved course and remitting the signed court copy of the completion certificate to the court before the expiration of the approved 90-days.
