<u>Procedure for Filing Petition for Occupational Driver's License</u> In the Justice of the Peace Court

The requirements necessary to obtain an Occupational License are outlined in the Transportation Code in Section 521. Basically, these requirements are as follows:

- 1. There must be an essential need for the Court to issue an occupational license.
- 2. A petition must be filed at the Justice of the Peace Court and County where:
 - a. A person resides:

- b. In the Court where the Offense occurred
- 3. The petition must include the following:
 - a. The reason the driver's license was suspended, and the length of time of the suspension.
 - b. The days and times necessary for travel. (No more than 4 hours a day, or 12 hours a day with cause shown, in any 24-hour day.)
 - c. The routes of travel requested, including the counties in the routes.
 - d. The petition must be in a format acceptable and suitable for filing at the Justice of the Peace Court. You may want to check with the clerk on this issue.
 - e. A filing fee of \$54.00 will be collected at the time of filing petition (Money Order, Cashier's Check, Debit/Credit Card w/ fee, or Cash.)
- 4. A DPS abstract of driving record must be filed with the petition along with proper proof of financial responsibility or SR22.
- 5. After filing the petition, the Court will set a date for hearing.
- 6. The Justice of the Peace will hear the petition at the set time and either Grant or Deny your petition at the time. If necessary the County Prosecutor may be asked to sit in the proceedings depending on the circumstances of your suspension.

If you have any questions regarding filling out the Petition or any legal questions regarding this matter, please seek legal advice thru an attorney; the court clerks may not answer such questions.

- b. The court must grant the issuance of an occupational license beyond one year.
- 4. Payment of reinstatement fees.

Waiting Periods

An occupational license is issued once the request is processed unless one of the following situations applies:

- 1. The individual's driver license was previously suspended as a result of an alcohol- or drug-related offense then there is a 90-day waiting period.
- 2. The individual's driver license was in suspension as a result of an intoxication-related conviction then there is a 180-day waiting period.
- There are at least two administrative license revocations on the individual's driver record then a mandatory one-year waiting period applies.

Individuals Not Eligible

If an individual's driving privilege is currently suspended, revoked, cancelled or denied under any law in the State of Texas, then an occupational license will not be issued to operate a commercial driver license.

Driver Eligibility Status

For individuals who are required to submit compliance documents (i.e. certificate of completion, SR-22, etc.), their driver eligibility status will change from "ineligible" to "eligible" on the License Eligibility website once all documents have been processed and fees have been paid.

To demonstrate an essential need to operate a motor vehicle, you may attach additional documentation, such as a letter from your employer.
