The proposed tax rate is greater than the no-new-revenue tax rate. This means that Llano County is proposing to increase property taxes for the 2023 tax year.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Llano County is not required to hold an election at which voters may accept or reject the proposed tax rate. No-New-Revenue Maintenance and Operations Rate Adjustments

Indigent Defense Compensation Expenditures

The Llano County spent \$124,639 from July 1, 2022 to June 30, 2023 to provide appointed counsel for indigent individuals in criminal or civil proceedings in accordance with the schedule of fees adopted under Article 26.05, Code of Criminal Procedure and to fund the operations of a public defender's office under Article 26.044, Code of Criminal Procedure, less the amount of any state grants received. For the current tax year, the amount of increase above last year's indigent defense compensation expenditures is \$62,101. This increased the no-new-revenue maintenance and operations rate by \$0.00005/\$100.
