Please see below questions to the Debris Removal & Disposal RFP.

- 1. Page 20, Household Hazardous Waste/Terms and Definitions Section: states," HHW must be located within a designated disaster area and be removal from an eligible applicant's improved property or the right-of-way. HHW must be a result of a major disaster. The pricing sheet does not include a line item for the collection of HHW. Please confirm if County is requesting services for the collection of HHW and if pricing sheet will be amended to include the collection of HHW material. Household hazardous waste is defined on page 20, at this time the pricing sheet will not be amended.
- 2. E-scraps material is referenced on Page 19 under Terms and Definitions. The pricing sheet does not include a line item for the collection of e-scrap. Please confirm if the County is requesting services for the collection of e-scraps and if pricing sheet will be amended to include the collection of e-waste. On page 19 e-scrap is defined, at this time the pricing sheet will not be amended.
- 3. Section 6.13 of the RFP asks to provide a completed copy of the Form CIQ and that a copy of the form is attached. However, there is no form attached to the RFP. Will the county be providing this form or should we download one from the website? Please see the forms included in the response.
- 4. Section 6.14 Byrd Anti Lobbying Amendment, this also says the certification is attached and must be submitted with proposal. However, there is no form attached to the RFP.
