The amendment does not provide authority for increasing ad valorem tax rates."

"Enmienda constitucional que autoriza a la legislatura para permitir que un condado emita bonos o pagarés a fin de financiar el desarrollo o redesarrollo de un área improductiva, subdesarrollada o deteriorada y de dar en prenda del pago de dichos bonos o pagarés, aumentos de la tributación al valor impuestas por el condado en bienes del área.
